



REGISTRATION RULES FOR APT MATCHES

1. REGISTRATION START

All the dates of APT matches and dates of their registrations are uploaded in advance to calendar on websites of the Czech IPSC Association - ipsc.cz as well as on the club websites (Calendar) alsaproteam.cz.

2. CONFIRMATION OF REGISTRATION

After completing the registration to the given match, each shooter will receive a confirmation e-mail with registration summary and bank details.

Registration, status and squadding can shooter check any time on the registration website of the given match. There the shooter can find as well the payment details (could happen that for some reason the registration mail goes to SPAM or is not delivered).

Registration to the match doesn't guarantee participation in the match. Match participation is confirmed only by starting fee payment.

Unless otherwise stated, prematch is primarily intended for Range Officers and possibly for approved sponsors. Shooters who sign up to squads marked as 'RO and sponsors' will be automatically transferred to the Waiting list.

IMPORTANT: It's not allowed to register to more divisions (e.g. 2 different handgun or combination handgun and PCC) in the same match.

In case of any questions or requests please ALWAYS contact Match Director (contact on the registration website) or send an e-mail to: ipsc.apt@gmail.com.

3. PAYMENT

Payment of the starting fee is necessary to send to **bank account of organizer within 14 days from registration**.

When the shooter pays the starting fee, it is required to include **shooter's name** (or shooter's number) **and match name** in the field „Payment details“/“Notes for recipients“. It is key for identification of payment. If the shooter send the payment for more shooters, it is necessary to include all names (shooters ID). Organizer apply the „first paid-first served“ rule.

After receiving the shooter's starting fee payment, the status of given shooter is changed from red to green.

Payments are checked twice a week. If your status remains red for more than one week after paying the starting fee, please contact us at ipsc.apt@gmail.com.

4. STATUS OF SHOOTER AND SQUADDING

Sending the payment on time guarantees to the shooter place in the match as well as in chosen squad.

Registered shooters who don't pay within 14 days from registration will be moved to Waiting list and their places will be offered to other shooters.

To those shooters will not be possible guarantee their original places in squad even in match (see the rule 6).

If the payment is not sent within 1 month from registration, those shooters will be deleted from the match. Free places will be continuously offered to other interested shooters.

5. REGISTRATION CHANGES

Application doesn't allow the shooter to edit or delete the registration. That's why you should always contact organizer as soon as possible on e-mail ipsc.apt@gmail.com to provide the changes (squad, division, category, name,...).

Shooter can request the squad change only in case there is a free slot in given squad or if he/she is agreed with other shooter (both shooters have to confirm the change via e-mail).

Deadline for squad changes is 3 days before the official start of the match.

Requests to squad change during the registration to the match at the shooting range may not be accepted.

6. WAITING LIST RULES

- a. If some slots become available in the main match, registered shooters from the „waiting list“ will be accepted to those slots only in case the starting fee is paid.
- b. Shooters from the „waiting list“ are accepted to the main match in the order in which they registered on the „waiting list“ - according to the starting number (not valid for those who were moved from main match – they will be at the end of waiting list) and then according to the credited payment.
- c. The organizer primarily fills vacant slots and only afterwards (if the situation allows this) can possibly meet the requirements for a specific shift or squad.
- d. In case the shooter from the „waiting list“ pays the starting fee and it is not possible to accept him/her in the match, the starting fee will be returned to the competitor's account, no later than 1 week after the end of the match.

7. MATCH DIRECTOR PERMISSIONS

Match Director reserves his/her right to make any change if needed, including the shooter's squad change !!!

8. DEADLINE FOR CANCELLATION OF PARTICIPATION

Any competitor who has paid the starting fee can request a refund of the fee at any time **up to 30 days before the official start of the match** (prematch day). The starting fee will be returned to shooter's bank account, no later than **1 week after the match**.

The starting fee for foreign shooters will be recalculated at the current exchange rate on the day the starting fee is returned.

The organizer **does not refund the payment less than 30 days before the official start of the match**. However, the slot can be sold or transferred to another participant – the ‚seller‘ always reports the change to the e-mail ipsc.apt@gmail.com.

9. CHANGE OF THE MATCH DAY

The organizer reserves the right to change the date of the match. The date change must be announced no later than 14 days before the original match date.

Payment deadline for the match with changed date remains unchanged and rule 8. DEADLINE FOR CANCELLATION OF PARTICIPATION still applies.

10. INEVITABLE ACCIDENT

In case of a date change due to force majeure reasons (eg epidemic, pandemic, natural disaster, etc.) the entry fee is not refunded but is fully transferred to the new date.

All disputes arising between the organizer of this match and the sports shooter participating in this match will be decided with finality, excluding the jurisdiction of general courts with final arbitration proceedings before the Arbitration Court at the Chamber of Commerce of the Czech Republic and the Chamber of Agriculture of the Czech Republic in Prague according to its rules of procedure.

11. MATCH INVITATION

The Match Invitation for each APT match is available as PDF document for download at the registration website of the given match.

If you require a notarized Match Invitation, you will be charged the costs associated with notarisation and postage. These costs will be collected from shooters at the shooting range in cash during the registration for the match. In this case you have to contact organizer no later than 90 days before official start of the match.

12. READ RULES OF IMPORT WEAPONS AND AMMUNITION

ATTENTION!!! Please, read properly the rules for importing weapons and ammunition. These rules are applicable not only to the Czech Republic, but also to the entire area of European Union.

13. GDPR

By completing the registration, the shooter expresses consent to the processing of personal data for ALSA PRO TEAM, z.s., with registered office at Kollárova 8, 612 00 Brno, Czech Republic, VAT nr: 03736482, entered in the public register kept at the Regional Court in Brno, file nr.: L20287 (hereinafter referred as the „Administrator“) to process the following personal data in accordance with General Data Protection Regulation EU 2016/679 (GDPR) and Act. No. 110/2019 Coll., on the protection of personal data:

Name and surname, e-mail, category (general information about age and sex of the shooter), photos and videos made by organizer for marketing purposes of the matches.
